Academic Information

Assessment

Depending on the module, different types of assessment may apply, for example: group assignments, presentations, reports, oral, and written exams.

Credits

The university grants ECTS credits (European Credit Transfer System). A full-time student can take a maximum of 30 ECTS credits per semester or 60 ECTS credits per academic year. Students must take a minimum of 12 ECTS per semester. The Module German for Beginners can be added to the maximum of 30 (total of 32) ECTS. 30 ECTS credits require approx. 900 student work hours. These include attendance during contact lessons, assignments, preparation, and examinations etc.

Grading System & Transcript of Records

Students receive a Transcript of Records, which includes Swiss numerical grades.

Swiss-European Mobility Programme SEMP (formerly Erasmus)

Within Europe, student exchanges occur under the umbrella of the EU Erasmus+ programme for education, training, youth and sports. Since the academic year 2014/2015, the funding required on the Swiss side has been provided through the 'Swiss-European Mobility Programme', SEMP (formerly Erasmus). The requirements for exchange semesters remain the same:

Your institution must have a partnership agreement with BFH. You can check this by contacting your institution's International Relations Office.

You must have completed the second semester before beginning your time abroad.

You must be proficient in the study language(s) of Bern University of Applied Sciences.

Matriculation and grants

During the SEMP placement, students remain matriculated at their home institution. Students do not have to pay tuition fees at the Bern University of Applied Sciences. During their time in Switzerland students will continue to pay tuition fees at their home university.

Grants are issued under the SEMP mobility programme. The paid-out amount is CHF 1900 or CHF 2200 per semester, depending on the country of origin of their higher education institution.

The duration of the courses followed at the host institution (welcome days and exams excepted) determines the amount granted for the entire duration of the stay (the allowances below cannot be combined).

- Duration between 3 months + 1 day and 7 months: regular grant, usually applicable to 1 semester or 2 terms

- Duration between 7 months + 1 day and 12 months: yearly grant, usually applicable to 2 semesters or 3 terms

Application and Requirements

Incoming Exchange Students

There must be an exchange agreement between Bern University of Applied Sciences and your home university(*). Then the following process applies:

Students get nominated by their Mobility Coordinators. The coordinators of the partner university should send the nominations to international.business@bfh.ch

The following details should be listed: Student name(s), email address, the field of study at home university, study programme at BFH, level of study, date of birth.

(*): Freemover: please send your inquiry to international.business@bfh.ch

Requirements:

- ✓ **Level of Study:** students should have collected at least 60 ECTS credits or the equivalent of within a Bachelor in Business Administration or similar degree programme at their home university.
- ✓ **Language requirements / English:** students must prove a solid B2 or higher English language proficiency in the Common European Framework. We accept all certificates which test all functional areas (reading, listening, speaking, writing). Students, who wish to attend modules of MSc Digital Business Administration must prove a solid C1 English language proficiency.
- ✓ **Language requirements / German:** students, who wish to attend modules offered in German but who are not native speakers of German should have German language proficiency equivalent to level C1.

Nomination deadlines are:

31 March for the upcoming autumn semester

30 September for the upcoming spring semester

We will contact nominated students and send a link to the application form.

Once applications have been assessed, we will send a Letter of Acceptance and further information about the exchange semester.

- ✓ Transcript of Records of past semesters at your home university (at least 60 ECTS)
- ✓ Confirmation of English language skills: B2
- ✓ Confirmation of German language skills: C1 (if you choose modules conducted in German)
- ✓ Photo (JPG-format, colored, min. 196x245 Pixel)
- ✓ Copy of passport

Double Degree Students

Double Degree agreements have been established with selected partner universities, enabling bachelor students to complete their final year at the BFH Business School and graduate with two bachelor's degrees. The home university is responsible for the application process and the selection of students. Students must apply directly at their home university to get nominated at the BFH Business School.

There are additional costs for course materials (photocopies, books) of approx. CHF 800. During a module, students will need a laptop and a broadband Internet connection at home.

Visa Requirements

To enter the country, foreign nationals need a valid travel document, recognised by Switzerland. In some cases, a visa is also required. In addition, all international students must submit a residence application, financial proof, and take out health insurance on their own behalf. Health Insurance

It is mandatory to have a health and accident insurance policy for stays longer than three months in Switzerland. A basic insurance plan covers medical care in the case of illness or accident. After arriving in Switzerland and registering with the municipality of residence, students have three months to take out health insurance. Provided students register within this time, they are insured from the time they entered Switzerland.

Students are responsible for taking out health insurance themselves.

Persons from the EU/EFTA area who have a [European health insurance card](#) are exempt from taking out health insurance in Switzerland. They do not need to take any action. Students from non-EU countries whose health insurance schemes are recognised by the Swiss authorities can, on application, exempt themselves from taking out health insurance. Please check that your health insurance scheme covers you in Switzerland.

Costs for residence permit:
The immigration authorities will raise an administration fee for issuing your residence permit. The costs vary depending on country of origin and are subject to change.

Financial Proof

For non-Erasmus students:
To obtain a residence permit, students must prove to have sufficient financial means for their stay (minimum CHF 1500 per month). This proof can be any of the following: a personal bank statement (authorized bank by [finma](#)), confirmation from the person who is financially supporting the student (including their bank statement and copy of their passport), and/or a grant certificate.

Student Life in Switzerland

International Family Mentor Programme



At the BFH Business School, we have an "International Family" arrangement, where each exchange and international degree student is assigned to an international family. Each international family has two mentors. These are BFH students who volunteer to help one or more of our international students in getting through the first few weeks in their new surroundings.

ESN

ESN is a Europe-wide student organisation, which works for the social and personal integration of exchange students. This work involves organising welcome parties, events, excursions, and personal support during the stay abroad.

The city of Bern has an excellent public transportation system, which extends to neighboring suburbs and towns. A special ticket is available for approx. CHF 60 per month for students under 25. Bern's central location makes it a perfect point of departure for excursions throughout Switzerland. The Swiss Federal Railways offers a railcard (Halbtax-Abo) for approx. CHF 165 per year.
